Do SWOT analysis for compassionate literacy program- When homeless person or candy seller approach a resident for money in the subway in New York city, ask them if they could read book on chastity, self-control or brahmacharya and write book report about the subject on the book. Contact information of provider and supplies needed will be given. When each book report is made \$200 is given as a stipend. Homeless persons get benefit of money. Books about chastity are preserved. Young adults can use the output book report to stay away from misuse of lust in school years and do excellent school and work performance.

# **Strengths**

# 1. Provides Direct Financial Support

- A \$200 stipend per book report offers meaningful short-term financial relief for homeless or low-income participants.

#### Weaknesses

# 1. Practical Barriers for Participants

- Completing a book report requires time, focus, and writing supplies—difficult to sustain in unstable living conditions.
- Not all participants may be comfortable reading or writing in English.

## 2. Ethical Sensitivity Around Topic Choice

- Asking vulnerable individuals to read texts about chastity or self-control may feel moralizing or coercive, even if payment is offered.
- The thematic content may not align with participants' own priorities or cultural backgrounds.

# 3. Verification and Quality Control

- Ensuring reports are genuinely written by the participants (not purchased or copied) may require oversight.
- Reading levels and report quality may vary drastically, which complicates distribution or reuse.

## 4. Cost and Scalability

- At \$200 per report, costs could escalate quickly.
- Funding, tracking payments, and administrative work would require a structured organization or nonprofit.

#### **Opportunities**

# 1. Partnerships with Shelters, Libraries, and Literacy Programs

- Concerns that the program promotes a specific moral agenda rather than addressing actual needs like housing or mental health care.

# 2. NYC Subway Regulations

• The MTA has rules on solicitation, distributing materials, and certain types of interaction; the program may face enforcement or complaints.

#### 3. Safety Risks

• Approaching strangers in subways—either residents or homeless individuals—can involve safety risks, misunderstandings, or escalations.

#### 4. Sustainability and Dependence

- If the stipend becomes a primary income source, ending the program suddenly could harm participants.
- Ensuring consistent funding is challenging.
